## County Code §2-8.9, Living Wage for County Service Contracts

**Effective October 1, 2018 to September 30, 2019**

### NOTICE TO ALL EMPLOYEES PROVIDING COVERED SERVICES FOR MIAMI-DADE COUNTY ON COUNTY SERVICE CONTRACTS

**LIVING WAGE** You must be paid not less than the wage rate in the schedule posted with this Notice if the kind of work you perform is a covered service under County Code Section 2-8.9.

**PENALTY** Damages payable to Miami-Dade County in the sum of up to 60% of the value of the underpayment may be assessed for failure to pay the required wage rates posted below in addition to payment for the underpaid wages to the employee; and/or up to five hundred dollars (\$500.00) for each week for each covered employee found to have not been paid in accordance with the Living Wage.

**SUBSISTENCIA** A usted se le debe pagar al menos la tasa salarial que aparece más abajo sombreado en esta nota si el tipo de trabajo que usted realiza se considera un servicio cubierto por la sección 2-8.9 del Código del Condado de Miami-Dade.

**MULTAS** Se le impondrán multas por un valor de hasta un 60% del pago retroactivo correspondiente al trabajador, éste es en adición a la cantidad que se le deba a los trabajadores por no pagar los salarios establecidos abajo. También hasta \$500 a la semana por empleado que no recida la tasa salarial obligatorias que constan a continuación.

**\$13.44 per hour with qualifying health benefits valued at least \$1.94 per hour, otherwise \$15.38 per hour (1.8172% increase from Fiscal Year 2017/2018 rate)**

#### LIVING WAGE FOR CONTRACTS FOR COVERED SERVICES ENTERED INTO, EXTENDED (BY EXERCISE OF OPTION TO RENEW OR OTHERWISE), AMENDED, OR MODIFIED ON OR AFTER OCTOBER 1, 2016 AND ALL SERVICE CONTRACTORS OPERATING UNDER PERMITS AT AVIATION DEPARTMENT FACILITIES:

**\$13.23 per hour with qualifying health benefits valued at least \$3.17 per hour, otherwise \$16.40 per hour (1.5480% increase from Fiscal Year 2017/2018 rate)**
